A WORD FROM THE EXECUTIVE DIRECTOR

What can we say about 2022? Wow! Not just Wow, but WOW!!! 2022 brought many exciting opportunities and some difficult challenges. During the year we baptized fifteen men. We had a record number of applicants and admits. We finalized a successful merger with FreshStart Visions, expanded the number of men we provide services to and added four staff members. We also integrated Munissions Re-entry Software into our operations and launched a pilot CDL training program in which five men received their CDL permits in Phase I training.

As we move into 2023, I first want to thank all of our supporters, whether you are a volunteer, a board member, a staff member, a prayer warrior, a partnering organization or agency, and/or a donor, I want to send you all a great big THANK YOU! Without you all, we could not help those we serve, begin to transition from the devastation of their past to a thriving future.

One of my greatest honors this year has been the opportunity to baptize fifteen men. As a pastor, sharing the Gospel, seeing people respond to the Gospel, and baptizing the men is my greatest pleasure and privilege. In 2022, we baptized more men than we have ever baptized in a single year. I believe 2023 will see greater spiritual activity in the lives of our men.

Because of your investments of time and money, SHIELD Ministries' estimated annual Economic Impact for 2022 was over 3.2 million dollars to our local community and state. This includes a direct savings to our SC Prisons of over 1.2 million dollars. Our donors' financial ROI is estimated at 889.2%, and more importantly, priceless eternal investments in many men's lives! Thank you again for you service and financial support.

We also completed a successful merger with FreshStart Visions. I want to send a special thank you to Tim Terry, Stephen Dickson and all the former FreshStart Visions Board of Directors, Amy Haley, the SHIELD Board of Directors, and Melodie Truluck, for all their hard work and dedication to seeing the merger successful. As a result of the merger, we are currently able to provide services to a maximum occupancy of 50 men and SHIELD Ministries now has a presence inside the prison through the MIT (Men In Transition) program. Another special thank you to Tom Pace and all the FSV volunteers who have combined their efforts with SHIELD to ensure the MIT program did not lose momentum during the merger and have continued on as volunteers with SHIELD.

2022 also presented challenges as well. As we have looked at expansion in Colleton County for 2023, we have met some opposition from the community. We have begun addressing these concerns and fully anticipate moving forward in anticipation of our occupancy in late Fall of 2023. This will increase our occupancy to 105. 2023 is going to be a great year for us! We look forward to expanding our prerelease program into 3 more prisons for a total of 5; continuing to expand our Cognitive Learning Program in both pre and post release; further refining our efforts to assist men in identifying and overcoming alcohol and drug addiction triggers; and continuing to grow our Workforce Development services, as we seek to increase in partnerships, employers and other nonprofits.





PRISONERS SERVED

Since May 1, 2022





65 men were served in the twelve week Men In Transition Program (MIT) in the SC Department of Corrections (SCDC). Two classes were held at MacDougall Correctional Institution with 46 men graduating from the program. One class was held at Allendale with a total of 19 graduates.

Men are eligible to apply for the MIT class between 12 and 18 months prior to their release date.

APPLICATION REFERRALS

SHIELD Ministries works closely with various law enforcement and government agencies, other nonprofit organizations and other community public and private service organizations to deliver individualized and comprehensive prison re-entry services. In 2022, 48.8% of SHIELD Ministries applicants* were referred from law enforcement agencies; 17.2% from other government agencies; and 15.8% from other nonprofit organizations totaling 81.8%. The remaining 18.2% were referred from the general public and 5.6% of the referrals being affiliated with SHIELD Ministries.

Many government and service agencies assist their clients in searching and applying for a program which includes housing. For these agencies and organizations, being able to refer their clients, who are often times hard to place, is one indeterminable benefit which SHIELD provides.

THE COMMUNITY OF HOPE PROGRAM

The SHIELD Ministries Community of Hope Program is an educational program which includes 5 pillars of service for men who are re-entering into society with criminal backgrounds or current charges (Prison, Prison re-entry and Prison Intervention). Men begin their Journey of Hope through our 5 areas of service categories, which are Crisis Stabilization, Regulatory Compliance, Cognitive Learning (Life Skills), Workforce Development and Spiritual Development. All our services are designed to meet individualized needs which have been identified by multiple research government and educational researchers as risk factors for a successful reentry. All our direct services, together, address the risk factors which directly have been shown to contribute

The Harvard University Institute of Politics Criminal Justice Policy Group reported "research showed that several dynamic risk factors – namely health, employment, housing, skill development, mentorship, social networks, and organization type – significantly affect the success of reentry. Thus, community-based organizations aiming to facilitate successful reentry and reduce recidivism rates should place special emphasis on addressing these risk factors."

Services provided under the Crisis Stabilization category include housing, food, clothing, hygiene, medical care (health and mental health care), legal identification and transportation to meet participant needs. One of the highest priorities of a majority of our students is to comply immediately with law enforcement registration requirements. Our Re-entry and Resident Support Specialists ensures that new admits are transported to and register with the SC Probation, Parole, and Pardon Services and the Sheriff's Office if applicable. This, along with providing internet accessible device monitoring and partnering with professional counselors who provide onsite counseling services are major components of our Regulatory Compliance Services.

Once these priority needs are met, men then begin classes and are referred to work, typically with our partner temporary agencies. Men begin with temporary agencies to become acclimated back into the workforce as they begin to learn about how to become assets to their employers in their Career Readiness Class. Men are immediately enrolled in the His Way Ministry's Friday evening Mentorship Program.

"The His Way Ministry family meets once a week to share our experiences, strength, and hope in a safe environment. Students continue through comprehensive studies designed to teach men how to think, learn, and succeed. The Core Educational Track takes on average 18 to 24 months to complete.

CRISIS STABLIZATION

HOUSING

14,915 Nights of Housing

105 men spent a combined total of 14,915 nights in the SHIELD Ministries Program in 2022.

"Stable housing with appropriate supportive services is a key factor in preventing homelessness and reducing recidivism. The goal is to reduce barriers to public and subsidized housing, and advance promising models that improve outcomes for people who repeatedly use corrections and homeless services."

SC PROBATION, PAROLE AND PARDON SERVICES


45 Men Receiving 30 Day Program Fee Assistance (1,191 Nights)

SHIELD Ministries is one of nine programs in South Carolina who received an award from the SC Probation, Parole and Pardon Services to help probationers pay for the first 30 days of their re-entry housing program fees. SHIELD's educational program includes housing and students pay \$23.57 per day to participate in the Community of Hope Program. Discounts for monthly and fixed income payers are available.

76 Welcome Packages

Upon admittance men receive a welcome package which includes sheets, pillows, blankets, towels, washcloths, toilet paper and hygiene packs.

FOOD INSECURITY



"Food insecurity is an often-overlooked consequence of incarceration, and it can't be separated from the more well-known problems of homelessness and unemployment. While the estimates vary somewhat, researchers consistently find that food insecurity is more common among formerly incarcerated people."

37,288 Meals Provided

As the Re-entry Coordinating Council reported to Congress in April 2022, Food Insecurity is one of the barriers of successful re-entry. SHIELD Ministries is a local partner agency of the LowCountry Food Bank and also receives donations from Delancey Street Foundation and churches. It is estimated that our food pantry provides 2-3 meals per day for our students who have spent a combined total of 14,915 days in the program. The estimated number of meals provided is 37,288.

TRANSPORTATION


Transportation is provided to students directly by staff, volunteers, upon entrance and also by bus passes. One of the Regulatory Compliance services offered is transportation to the SC Probation, Parole, and Pardon Services and the Charleston County Sheriff's Office, if applicable, for registration.

678 Trips Provided

178 trips were direct transportation services provided by staff and volunteers.
500 trips provided through Bus Passes (bus pass trip detail is not included in the graph below).

Transportation is considered a Crisis Stabilization and Regulatory Compliance service depending on where the participant is transported. SHIELD Ministries' prioritizes registration with Law Enforcement agencies as one of the highest priorities of newly admitted students along with medical/mental health. The next priority is assisting students with obtaining identification.



STUDENT REFFERAL AND PARTNER SERVICES

One of our guiding principles has always been not to duplicate services but to refer, partner with, and establish close working relationships to fill the gaps of service for the re-entry population. We do not seek to compete but to "complete". What this means is that we seek to provide our students with comprehensive and individualized services directly or through referrals to other governmental agencies, health care providers and nonprofit organizations. The impact is that our students receive specialized services and there is not a duplication of services. This core operational standard has proven efficient and effective in time and cost savings not only to the organization but to our donors, governmental agencies and other nonprofit organizations. Results provide a greater impact for our students through the diversity of service providers.

MUNISSIONS RE-ENTRY SOFTWARE

In 2022, we implemented Munissions Re-entry Software System. Our re-entry specialists use Munissions for student assessments, goal planning, progress tracking, and referral services. Through Munissions we are able to capture student data, responses, assessments, and activity which automatically feed into Munissions. Another vital industry module of Munissions is the ability to perform readiness to change predictions using the URICA scale (University of Rhode Island Change Assessment Scale). It additionally reports on the risk of recidivism through multiple assessments as well as goal tracking and individual data entry designed to identify criminogenic needs.

Munissions also provides the ability to refer our students out for professional care. The implementation of Munissions not only provides better outcomes for our students but it streamlines our processes and enables us to quickly identify and address necessary intervention measures.


UNIVERSITY OF RHODE ISLAND CHANGE ASSESSMENT

"The URICA is a 32-item self-report measure that includes 4 subscales measuring the stages of change: Precontemplation, Contemplation, Action, and Maintenance. (There is also a 24-item version.) Responses are given on a 5-point Likert scale ranging from 1 (strong disagreement) to 5 (strong agreement). The subscales can be combined arithmetically (C + A + M - PC) to yield a second-order continuous Readiness to Change score that can be used to assess readiness to change at entrance to treatment." https://pubs.niaaa.nih.gov/publicati ons/urica.pdf

"Criminogenic Needs are factors in an offender's life that are directly related to recidivism. Research has identified six factors that are directly related to crime: low self-control, anti-social personality, anti-social values, criminal peers, substance abuse and dysfunctional family."

16 Veterans Served

Of the 16 veterans who we proudly served in 2022, four were able to secure stable housing. In August 2022, a Preliminary Assessment of Veterans in the Criminal Justice System release reported:

"Justice Department data showed that about 8% of all U.S. inmates, or about 181,500, were military veterans. The preliminary assessment identified multiple risk factors that contribute to incarceration for veterans, including combat-related trauma and post-traumatic stress, traumatic brain injuries, substance abuse, adverse childhood experiences and sexual trauma while in the military." https://www.nbcnews.com/news/crime-courts/commission-will-study-veterans-are-likely-non-veterans-get-trouble-law-rcna44326

Dr. Caroline Leaf, states "true transformation requires mind-management strategies to rewire neural pathways. Directing the way your brain changes (neuroplasticity) transforms energy patterns in the brain, changes blood measures, and eventually establishes a new and healthy level of balance in the brain and body. You, like the study subjects, can use the Neurocycle to methodically use your mind to take advantage of neuroplasticity to rework your neural circuitry, managing and improving a variety of mental and physical states, even if you have very dysfunctional brain networks and physiology from toxic thoughts and trauma."

REGULATORY COMPLIANCE

Regulatory Compliance is the adherence to all governing laws which include court ordered counseling, register for Probation, Parole and Pardon Services, along with meeting specified rules and regulations of governing law enforcement. Over **15** men have been court ordered into our program. SHIELD Ministries assists men in understanding their responsibilities, rules, regulations and requirements.


SHIELD Ministries provides services through partnerships with treatment counselors who provide court ordered counseling onsite to ensure accessibility and accountability for attendance. Some specialized treatments also include regular polygraphs. Polygraphers are able to conduct their tests onsite. Additionally SHIELD Ministries provides transportation for men to meet their initial registration and ensures that men are meeting this requirement. Law Enforcement agents are able to access the property at any time for meetings and or searches.

We provide an optional weekly Worship service. Men on probation and men who are required to register as sex offenders are prohibited from attending churches, therefore this is service is consider a regulatory compliance service and a spiritual development service.

COGNITIVE BEHAVORIAL LEARNING

23 Graduates of the 105 who were enrolled in FY2022, were graduates of the SHIELD Core Program.

It generally takes between 18-24 months to complete the Core Program. This could vary due to the schedule of classes offered and the fact that program enrollees can enter the program at any time during the year. It is essential for students to meet all class requirements and attend all classes. Students who remain in the program after graduating participate in various assigned classes on a regular basis.





COURSE DESCRIPTIONS

SHIELD Ministries uses Cognitive Learning principles in classes focused on Life Skills, Workforce Development, and Spiritual Development. The courses descriptions listed below are courses offered as a part of the SHIELD Ministries Core Educational Program. Additional classes, such as GED/Math are offered as needed along with specialized classes such as Untangling Relationships.

Think, Learn, and Succeed: Understanding and Using Your Mind to Thrive at School, the Workplace, and Life (12 weeks):

Think, Learn, and Succeed, Author, Dr. Caroline Leaf explains: "How you understand and use your mind is predictive of how successful you will be. Nothing will work unless you get your mind right first. This book is all about helping you make that switch to a life well-lived, filled with meaningful success. This book is about helping you achieve your goals and dreams. This book is about mental self-care, which includes learning how to control our mindsets, the unique way each of us think, feel and choose and learning how to build healthy, long term memories. It takes you beyond mindfulness into a lifestyle of cognitive transformation." https://drleaf.com/products/think-learn-succeed-book

This class uses both the Think, Learn, and Succeed book and workbook to understand the science behind thinking and how to use your mind to learn through changing your brain through your mind, through neuroplasticity. This class is a pre-requisite for Healing of Damaged Emotions and Healing of Memories.

Healing of Damaged Emotions (20 weeks):

"Events in our lives, both good and bad, form rings in us like the rings in a tree. Each ring records memories that affect our feelings, our relationships, and our thoughts about God. In this classic work, David Seamands encourages us to live compassionately with ourselves as we allow the Holy Spirit to heal our past. As he helps us name hurdles in our lives—such as guilt, poor self-worth, and perfectionism—he shows us how we can find freedom from our pain and enjoy the abundant life God wants for us." It was through this study and the Healing of Memories study, where David Truluck, co-founder of SHIELD Ministries began his healing journey with Chaplain David Golden which would then led to the birth of SHIELD Ministries over 20 years ago. Chaplain Golden currently leads this and the Healing of Memories in SHIELD Ministries.

Healing of Memories (20 weeks):

"This book examines the work of the Holy Spirit in healing certain types of emotional and spiritual problems which cannot be solved without individual and careful attention. Time alone cannot heal the memories of experiences so painful that we've been pushing them out of our conscious minds for many years. Yet such memories continue to cause us emotional and spiritual problems. They must be dealt with directly and deliberately." WORKFORCE DEVELOPMENT

"The objective of workforce development is to create economic prosperity for individuals, businesses, and communities. Workforce development focuses on an individual's ability to grow their skills and develop the tools they need for business success. workforce development is built around learning rather than training." https://myworkchoice.com/blog/workforce-development/?utm_source=google.com

Work Readiness Class (4 weeks):

Students will learn the importance of communication in the workplace as they practice listening, speaking and writing. They will learn how to be direct in a positive way about their past criminal backgrounds. Students learn what character traits employers are looking for. The course also includes time management strategies which include the ability to prioritize using the 4 Ds: Do, Defer (Delay), Delegate, and Delete (Drop). While Financial Literacy is considered a component of Career Readiness, SHIELD offers that as a separate course.

Financial Literacy Class (4 weeks):

Financial Literacy is designed to help the student understand and effectively use various financial skills, including personal financial management, budgeting, and investing. The student will create a personal budget and financial goal plan. The student will obtain a checking and savings account or create a step-by-step plan on how to re-establish the ability to do so. Students will learn how to create payment plans so that they can successfully be able to pay back restitution including probation fees, child support, counseling fees, program fees, and/or ankle monitor fees.

CDL (Commercial Driver's License) Training Pilot Program Book Learning Phase I (5 weeks):

Four men received their CDL permit. In 2022, SHIELD Ministries launched a CDL Pilot Program with two phases. In Phase I, men studied the South Carolina CDL Learners Permit Manual in preparation to take the test. Five men were enrolled and four men were able to pass their CDL Permit test. In Phase II, men will enroll in the CDL driver's training at Palmetto Training. They are applying for WOIA funding to pay for this training.







EMPLOYMENT

SHIELD Ministries refers men to various temporary employment agencies within the first few days of release. As the men work in a temporary agency environment, this allows the men to acclimate back into the workforce as well as attend the career readiness class to prepare to transition to a full-time and then full-time permanent position. The end goal is for men to become gainfully employed. Men are expected to work and attend classes in the SHIELD Ministries Community of Hope Program.




SPIRITUAL DEVELOPMENT

SHIELD Ministries was founded through a calling of God as a result of a redemptive work of Christ Jesus in the life of David Truluck, Executive Director. In 2002, God used Chaplain David Golden, who provided spiritual counseling, as he led David Truluck through Healing for Damaged Emotions and Healing of Memories. God also used Dr. William Burke, Assistant Director of Psychiatry of MUSC, Assistant Professor, College of Medicine in the Department of Psychiatry and Behavioral Sciences, and private practitioner, to provide specialized counseling and treatment in conjunction with Chaplain Golden's mentorship and spiritual counseling. In addition, God used a small prayer team in a mighty way to not only facilitate David's inner healing but to birth SHIELD Ministries.

A major common factor that was realized in David Truluck's healing process in both the spiritual and physiological areas, was cognitive behavioral therapy/learning which was evidence-based and at the time considered "the gold-standard psychological treatment." https://www.ncbi.nlm.nih.gov/pmc/articles/PMC5797481/

We serve men will all types of religious backgrounds, however our classes are based on Christian Faith-based principles and are scientifically evidenced-based.



WORSHIP & PASTORIAL SERVICES

We offer optional worship services to our men. Men who are on the Sex Offender's Registry and are on Probation are prohibited from attending churches. In 2022, there were 15 men who were baptized. Additional Pastoral services provided are spiritual counseling, grief counseling, hospital visits, and officiating funerals.

South Carolina is reported to have a 21% Recidivism Rate, the lowest in the United States.

"Recidivism is when a person who has committed a criminal offense and has been convicted of repeating a crime or reoffending after already receiving punishment or serving a sentence. The term "recidivism" is primarily used in regard to substance abuse and criminal behavior, but also in medicine where the term "recidivism" is a synonym of the word "relapse". ESTIMATED ECONOMIC IMPACT

Programs like SHIELD help alleviate the public's burden of cost of incarceration. A 2017 report from the United States Department of Justice's Bureau of Justice Statistics outlined what the expenditure costs which taxpayers fund through our government:

"In 2017, county and municipal governments spent nearly \$100 billion on police protection and nearly \$30 billion on corrections.

Real (inflation-adjusted) justice system expenditures increased 62% from \$188 billion in 1997 to \$305 billion in 2017.

State governments made nearly \$50 billion in direct expenditures for corrections activities, 88% of which were for correctional institutions.

Numbers of full-time equivalent (FTE) employees in state and local justice systems grew 16% from 1997 to 2007, then fell 1% from 2007 to 2017." https://bjs.ojp.gov/library/publications/justice-expenditures-and-employment-united-states-2017
